Paul Trisley was a highly regarded sports lawyer and one of ANZSLA's most dedicated members for many years. Paul died in 2001 and this award acknowledges his tremendous contribution to ANZSLA and the area of sports law generally.

At its annual conference each year, ANZSLA presents this award to a person who has never presented at an ANZSLA event or been previously published in the ANZSLA Journal, and who, in the judges' opinion, submits the best paper in accordance with the award guidelines. The judging takes into account the paper's accuracy, originality, practical value to sports administrators and lawyers, and its academic quality.

The winner will receive from ANZSLA:

- The Paul Trisley Award presented at the 2025 Conference dinner on Thursday, 23 October
- Full registration at the 2025 ANZSLA Conference in Brisbane, Australia
- Return air travel to and from the 2025 ANZSLA Conference (Australasia only)
- Two nights' accommodation during the 2025 ANZSLA Conference
- One year's ANZSLA membership

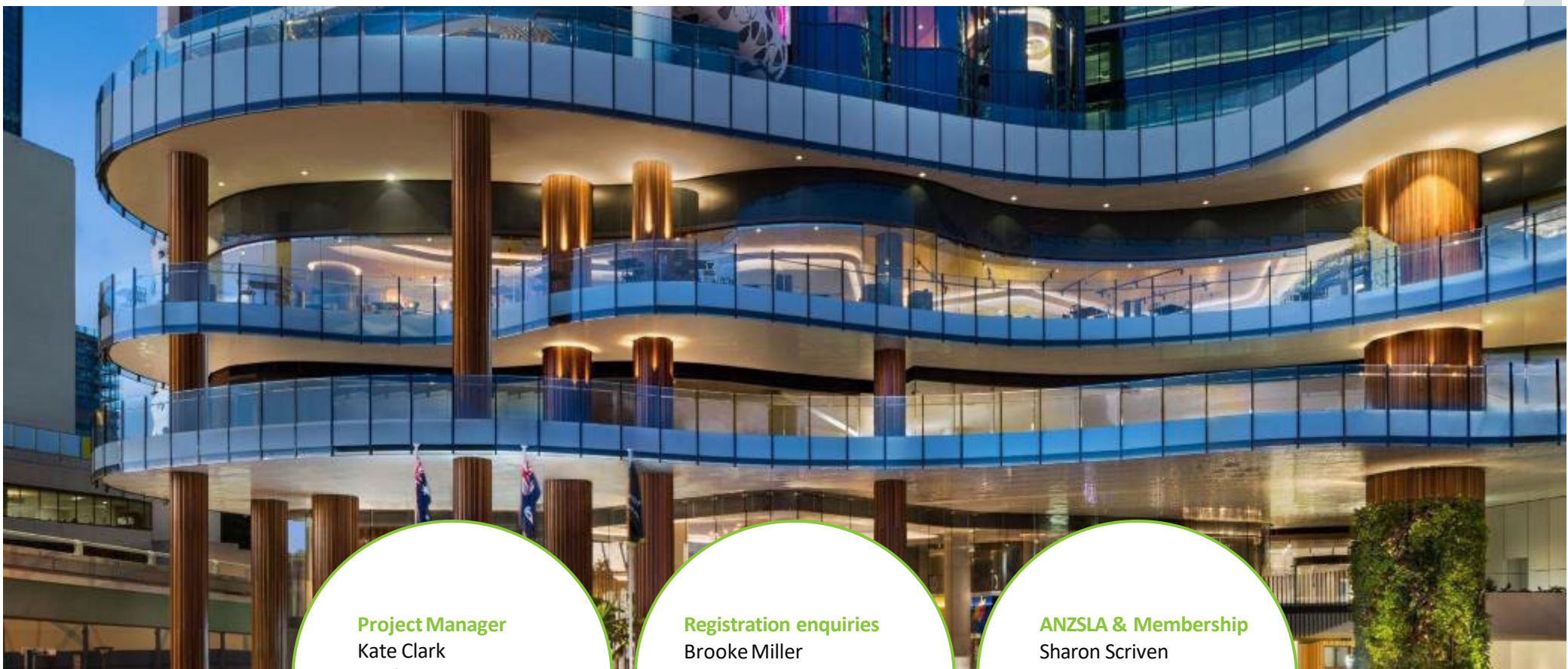
