

## Denis Callinan Award

1. In memory of Denis Callinan, a well respected lawyer and ANZSLA member, ANZSLA has created the Denis Callinan Award.
2. The Denis Callinan Award is sponsored by the Queensland Traffic Offenders Program of which Denis Callinan was a founder.
3. The Denis Callinan Award is intended to recognise ANZSLA members who render commendable community service in the field of sports law. Examples of such service may include voluntary work in:
  - a. Membership of sport related tribunals or panels;
  - b. The provision of pro bono legal advice to sports organisations or persons who would otherwise be unable to afford such advice
  - c. The provision of assistance in relation to the governance and constitutions of sports clubs or associations;
  - d. The provision of assistance in the preparation of publications or training concerning legal issues affecting sport; and
  - e. The organisation of or participation in presentations, seminars, and other sport related education..
4. The inaugural recipient of the award was presented at the 2012 ANZSLA Conference in Perth to Andrew Gibson in recognition for his outstanding contribution to community and grass roots sports and particularly for his assistance to the Play by the Rules program.
5. The Award will be made annually at each ANZSLA annual conference, subject to clause 9.
6. Members are encouraged to nominate fellow members, or may self apply. Nominees must be current ANZSLA members.
7. The recipient of the Award will be presented with a trophy in recognition of their outstanding community service, and the right to nominate an appropriate recipient of a grant of AUS\$2000 or NZ\$2000 (dependent on the country of the recipient and subject to the approval of the ANZSLA Board).
8. Nominations for the Award must be received by the ANZSLA Executive Manager no later than the first Friday in September.
9. The ANZSLA Board will consider the nominations received and decide whether there is a suitable recipient of the award from the nominations received,
10. The decision of the ANZSLA Board is final. The ANZSLA Board reserves the right to withhold the award if it believes that the criteria for the making of the Award are not satisfied from the nominations received.
